1. Apologies for Absence:

County Cllr Winnington. Proposed Councillor R Udall. Proposed Cllr S Downing did not attend the meeting.

2. Minutes of AGM 5th May 2021:

Councillor Hammond observed that he had not been included as an attendee of the last AGM despite having comments recorded. The Minutes were amended, accepted by councillors as a true record and signed by the Chairman.

3. Current Chairman's Report:

The Acting Chairman stated that whilst it had not been as busy as the previous year, some highlights were as follows:

- We welcomed the representatives of the Red Lion Support Group and supported them up to their appeal application. The appeal has now concluded and the decision to list the Red Lion as an Asset of Community Value had been upheld.
- The Chair thanked the Clerk for her support and correspondence including the ongoing issues with A519 safety and speed limits, fly-tipping and grants.

- Councillor Carver had kindly represented the Parish at a meeting to discuss the Golden Triangle Route.
- The Chair thanked David Carver for having continued to take the role of Responsible Financial Officer and his maintenance of the website and the

associated compliance of both and for securing the new mandate with NatWest Bank.
